Worthy Brothers, I need to point out a few things to you as your State Treasurer. Per Capita bills were mailed out in early July and many councils have already paid. Is your Council one of them? Ask at the next meeting. All bills are due upon receipt.

Next, the State Officers are hearing about councils that have been assessed by the IRS for non-payment of taxes which basically means you have not filed your tax forms for your Council and or Building Association? There is information in the Grand Knights Handbook, pages 253 – 294 and 356 - 361, handed out at the Grand Knight's Leadership Conference in June 2008. This includes information from our Supreme Advocate as well as IRS information. It is recommended that the Council enlists the help of a competent accountant as they go through this process. If you do not have your Handbook contact your District Deputy or the State Office.

In addition I need to speak about our annual Frank Fourgere State Raffle. Raffle tickets were given to every District Deputy at the Installation of State Officers on September 14th in Walpole. This past May 2008 a resolution was passed at the State Convention that states that every Council that does not participate in the State Raffle will be assessed \$1.00 per member. The resolution is on pages 236 – 237 of the


Grand Knight's Handbook handed out at the Grand Knight's Leadership Conference in June 2008.

Please know that the State Deputy is looking forward to each Council's participation in the State Raffle. This raffle generates \$5.00 per Council for every book of 15 tickets sold. The State Council is handling the expenses of printing and prize money.

Please, please just mail out the book of tickets to your membership, sell them after Mass, and sell them at your Council activities. such as the Basketball Free Throw. There are a hundred and one ways or more to participate in this raffle. Each Council has the ability to fund raise at \$5.00 per book sold.

For example, if a Council sells 100 books, that is \$500.00 profit. The \$500.00 can be used to sponsor a seminarian for the RSVP program.

# **Prospect Lists and Council Brag Sheets can be** The Key To Meeting our Recruitment Goals

There is a saying that if you don't know where you're going, any road will take you there. Unfortunately that is often true when it comes to recruiting because we often approach our council recruiting without direction. In our BLITZ and Church Drives, we caste a wide net hoping to attract interested Catholic men, while ignoring those friends and relatives that are most likely to join our council with some encouragement from us. We also usually do a fine job promoting the Knights of Columbus; while we fall short when it comes to promoting our own council.

As recruiters, we need to convince our prospects that he should join our council group. Let's face it; the man, who joins our order during a Church drive, would likely have joined sooner or later anyway. A well structured prospect list helps the council reach out to those men, who are "too busy" to join. A well crafted Brag Sheet or Council Brochure will help convince him why he should make time in his schedule to join us.

Each council should construct a list of at least twenty prospects. The Supreme Membership Recruitment Guide (#2769) offers many suggestions of whom we should include on the list. Fathers, sons, nephews, cousins and in-laws should find their way to the list. Our pastors may suggest parishioners, who are looking for parish community involvement. And don't forget to add former members to the list. Your area Regional Membership Chairman can secure, upon request, a list of former members in your council's zip code. Look especially for former members who are suspended from remote and out of state councils, as well as those former members of your council that may be ready to reactivate.

Each Council Officer, Chairman and Past Grand Knight should contribute at least one, probably two names. The list should be read at the council meeting and additional names should be solicited from the membership. Then no fewer than three members should be assigned to recruit the prospect. Remember again, we are asking the prospect to join our group. It makes sense for several members of the group to ask him to join. Seek out your prospects at the Church Drives and personally invite them to the Council's Open House. Again, Supreme provides professional invitations at no cost to the council.

Recruiters should stress the benefits of the order, as well as the activities and projects that the council will be involved in over the coming months and why the council believes the prospect might be interested and helpful. That is where the Council Brag Sheet comes in. The Brag Sheet can be as simple as a list of the upcoming projects. But today, every council has several computer savvy members, capable of putting together a professional looking council brochure. The Supreme Council puts out an

excellent flyer on How to Design Your Council's Brochure (#4125).

The Prospect List and the Council Brochure are two tools that can help focus our recruiting efforts. They help us plan, so we always know where we are going. If we use them properly they will keep us on the right roads to get us

# **WOMEN** -

The following contains the opinions of the speaker and not necessarily the opinions of the Supreme Knight or the Knights of Columbus

There is a widespread view among both Catholics and non-Catholics that women in general are viewed by the Church as second-class citizens. Critics would cite as evidence the fact that women are not allowed to be ordained priests or deacons. More immediately, they report personal experiences of women at the hands of clergy, even hierarchy, which caused them to feel underappreciated, if not abused by the "Church," or at least by some of the clergy.

I cannot confirm, deny or even comment on some women's personal experiences except to say many of these women remain dedicated to the Church, but still insist they have experienced things that cause them to feel undervalued. I would suggest that, as Church, each of us needs to be attentive to the way our behavior and our attitudes impact our fellow Catholics - male and female. One does not become a "better" Catholic because of one's gender or status.

What I can respond to is the suggestion that the Church's position on ordination of women, based as it is on the tradition established by Christ when He chose only men as His apostles and their selection of men as their successors, reflects a fundamental bias against women. However, in 1988, Pope John Paul II put to rest this argument in his aposletter MulierisDignitatem. There he made it absolutely clear and unmistakable that the Church views men and women as absolutely equal. Each was created for his or her own sake by God and each has a human nature which participates in the life of God. Our late Holy Father developed the relationship of women to the central story of human history the Redemption – not just through the major, even essential role of Mary, the Mother of God, but of many women whose stories we read in both the old and new testaments.

One has to be especially impressed by the way Jesus dealt with women – not just

holy women, but women of all Prostitutes, poor stripes. women, those begging for His help, mothers, single women indeed the entire spectrum of women He met in His travels. Jesus' involvement with women was not especially well regarded by the religious and political figures of His day. Talking with women, treating them with dignity and respect especially in public and even more especially on the Sabbath exposed Jesus to political and religious risks. He did it anyway.

Since the Church was founded, women have been held up as role models, not simply for other women, but for all of us. From the time of Christ, with the Blessed Mother, with Mary Magdalen, Mary and Martha, then through the ages with St. Monica, the mother of St. Augustine, to Joan of Arc, Rose of Lima, Elizabeth Ann Seton and Mary Ward, women have served as models of Christian virtue. The list could go on much longer adding e.g., St. Catherine of Siena and St. Teresa of Avila. Many others are mentioned in the Canon of daily Mass - Felicity, Perpetua, Agatha, Lucy, Agnes, Cecelia, and Anastasia.

The point is the Church, following the example of Jesus, has not relegated women to second class status, but has from its beginning and continues to honor and respect the dignity of women as equal participants with men in their human nature.

The apostolic letter of Pope John Paul II is a summary of many of his reflections on the subject of women – many of which demonstrate a profound regard for women that would surprise one whose only source of knowledge on the subject is the public media.

I want to move on from the official view of women by the Church to the current role and treatment of women in society.

Over the past forty years, certainly since the publication in 1963 of Betty Friedan's *The Feminine Mystique*, there has been an evolution, even a revolution, in the role of women. Women, however, remain the center of family life, the primary caretakers and educators of children, the supporters and companions of their husbands,

the ones responsible for the care of elderly parents and relatives, and fulfill m any other traditional roles.

While they have long been expected to fulfill these traditional roles and the attendant responsibilities, women were now being asked, no - being told - that their roles included so much more that. To use the phrase of the day - they could have it all and must have it all or be a failure. No longer was it enough for a woman to be the center of her family's life and her community's life, she now must be part of the "real world." She must include a career as part of her responsibilities. She must be a breadwinner for her family and herself and must develop all her skills, not just those that enhance her husband and her family and her church and her community.

She was, of course, not entitled to give up her prior responsibilities, but was required to add these new obligations to the already exhausting burden of her prior duties.

Society, which included the electronic media, women's groups, magazines aimed at women, books, academic studies and women's contemporaries reinforced and shaped these attitudes. A woman was expected to become educated, to enter the job market, to compete for promotions and to do all of this as well as maintain all of her other responsibilities.

No one told women it was impossible. Examples of "successful" women who were or appeared to be able to do both simultaneously were held up as the norm without any critical examination of their real success or their resources. The unexpressed point was – they can do it, so can you – so must you.

While all of this so-called empowerment was taking place, something quite different was also occurring. Some referred to it as the "sexual revolution," but it was a development that basically said sex and marriage were not related, women have as much right to sexual pleasure as men, women have as much right to sexual diversity of partners as men have had, and sexual relations and childbearing should be considered separate.

In addition, women were told and continue to be told that they must remain physically attractive, thin, clear-skinned, youthful, and sexually imaginative to their husbands and/or boyfriends. They must do whatever it takes - diet, exercise, makeup, hair coloring, plastic surgery, to offset the normal effects of aging, etc., etc., etc. Perhaps our mothers were not confronted with these demands, but our wives, our daughters and our granddaughters have been or will be. It seems inadequate and almost superficial to say it is not fair to women, but I will say it nonetheless. It is not fair.

Certainly, it is not fair that in the 21<sup>st</sup> century, we continue to objectify women. We do this in so many ways, but often we men look upon women in general as creatures designed solely for our comfort and pleasure. As Knights of Columbus, we cannot change society's view overnight, but what we can do is to resolve in our own lives to resist this view of women. We must respect the dignity of every woman, recognizing that men and women are different, that each has a special and irreplaceable role in society but that women are equal **partners** in our lives' journeys and not merely sources of our comfort and pleasure.

As men, we must resist the temptation to tolerate pornography, whether "adult" or "child" and the perverse treatment of women as sexual objects to be stared at, whistled at, admired primarily for their physical attributes and scorned if they fail to measure up to the current ideal size or shape. We should not continue to tolerate unflattering references to women in private or public conversation, whether black or white, because to remain silent in the face of those kinds of remarks, even by famous "artists" makes us collaborators and encourages more of the same. We must have the courage to confront this attitude and make it clear that we categorically reject it.

Identifying the proper role for women after forty plus years of cultural input, mass communication, education and training, is a much more complicated challenge. We cannot say for

certain that all of these changes in the roles of women are for the better. Certainly, more women are in the workforce, more are in colleges and universities where they have expanded their intellectual horizons, more are the major family breadwinners than ever before. But, simultaneously, more children are born out of wedlock, more women have abortions than they did forty years ago, more families are headed by single women and more families, headed by a single female parent, are living in poverty than ever before, or even more than contemporary two parent families are. The cause of these circumstances cannot be attributed solely to the so-called feminist revolution, but that development has not prevented these things from occurring.

What is clear though is that many women are unhappy, frustrated or despondent, because they believe they are failing at something or at everything. The demands of family, children's schooling, sickness, spousal relations and aging parents' needs - are adversely impacting their chances for success at the workplace, and elsewhere. To the exhortation that they should simply do more, try harder, put in more time at home or the office, sacrifice a little more, "leave it all on the field," their only response is that they can't. And it is true.

Why then do they even try? First, they are told they can. Second, they are told they must. Third, they are told they should because this is the way to have it all and live the good life. No one is saying to women "you have been sold a bill of goods. Cut back, focus on what you can and must do, for yourself and for your family. If this requires deferring a new car, a large home, an expensive vacation, so be it. No one can have it all simultaneously - no man no woman."

At the same time, we, as men, especially as Knights of Columbus, must recognize that there is no "one size fits all" solution to this problem. Many women find themselves having to work or needing to work. The response **needed** from men – husband, father, boyfriend – is to find ways to sup-

port them. We no longer can assume that cooking, shopping, housekeeping and childcare are solely the responsibilities of working women. These responsibilities must be shared and, by that, I do not mean men must help out on occasion. I mean, men must take over the primary responsibility for some or all of these roles.

To be sure, working or not working outside the home is not an easy choice for educated women who have deferred marriage and childbearing to complete their education. They worry about losing their place on the corporate ladder, paying off education loans, and they worry about the biological They worry clock ticking. about keeping up with the Joneses, appearing to be a failure to their peers and if they attempt to have it all, they worry about "quality time" or no time at all for their families.

These are real concerns and as a society we have done little to help women. We have not taken their concerns seriously and given priority to addressing their needs. For example, is it necessary for educated women to lose their place on the corporate ladder forever because they chose to have a family? Can society not address this issue through aggressive programs of part-time work, continuing education, at-home work, flex hours, job sharing, day care programs that are cost effective and safe, or through other programs that those more expert than I could propose? It is foolish to say such an effort would be ineffective or a waste of money.

Women's most serious issues today range from balancing home/work concerns to physical safety to being respected as women. These concerns must be taken seriously by all of us and not left solely to the women affected to work it out. The physical safety of women, for example, is everyone's concern, yet we design our cities where 115,000,000 women live, and our malls where the majority of shoppers are women, without giving their safety the priority in the design and implementation phases it deserves.

Finally, let me address one of the most divisive issues of the day and one that affects women in a unique and personal way and that is abortion.

Books have been written on this subject; dozens of legal opinions have been written; states have passed numerous statutes attempting to restrict abortions or to regulate them in some way or other. I will not even try to summarize it all here – even if I felt competent to try – which I don't. I will say this: The lot of women has not been improved by abortion. Indeed, society has not benefitted by the legalization of abortion.

Since the 1973 decision of Roe v. Wade there have been more broken marriages, more cohabitating, more children living in poverty, more women living in poverty, and more children born outside of wedlock than ever before. These are the conditions the advocates for the legalization of abortion argued would be improved if abortion were made legal. The back alley abortion - using the dreaded coat hanger which allegedly resulted in 10,000 deaths a year, was pure fiction. It was argued that out of wedlock births were to be reduced. It did not happen. Women who were pregnant would be able to end the pregnancy easily and without consequences. It did not happen. Divorces previously caused by the strain of too many children would go down. It did not happen.

Instead, most of the evils which were said to result from the lack of legal access to abortions worsened after abortion was made legal. The original rationale of the Court, dividing the gestation period into three trimesters and limiting the state's interest in preserving the baby to the latter two trimesters, has been replaced by the notion that abortion should/must be available at any time. Proposed legislation currently being considered in New York State would lessen protection for women while insuring that no limitations on abortion, however reasonable, prudent, or popular, would be allowed.

But my point here is not that abortion is bad because a baby's life is destroyed - though I certainly believe that. It is not even that the effect of the abortion jurisprudence has corrupted the legal relationships between a husband and wife (notice to the husband not required), doctor and patient (he must provide her with abortion advice, and a hospital with abortion services, but may not be required to advise her of the potential consequences - bleeding, death, breast cancer, depression, even suicide), pharmacist and customer (he/she must dispense abortifacient drugs, even if it violates his/her religious or conscientious beliefs), parent and child (notice to the parent of the pregnancy of and abortion to a minor child not required), though I firmly believe that jurisprudence has been so corrupted.

Rather, I believe abortion has been a disservice to women in large measure because it has deprived women of the information all people need and deserve when facing a serious medical procedure. Most women today do not obtain abortions from their personal physicians as Roe v. Wade assumed would be the case. The persons advising the woman or the girl regarding the abortion and certainly the physician performing the abortion is usually a stranger with little or no familiarity with or background knowledge of his or her "patient." By depriving women of the same level of information about the procedure (including the potential consequences) they would be entitled to receive, if they were being prescribed an antihistamine or penicillin, for example, the woman is simply treated as a passive pawn in the political battle between those who see abortion as an empowering tool for women and those who see abortion as tantamount to mur-Women deserve much more. Here again our society has chosen abortion to deal with social, family, employment and medical issues that could be addressed in many other more effective and less divisive ways and it ignores or hides the awful risks of abortion, including bleeding, breast cancer, depression, death or suicide. Society simply needs the will to address these issues and, when it does, the lot of women in our society will be improved.

In a study of women who have had abortions, one woman had this to say: "Before I had my abortion, which my family urged me to have, if just one friend had supported me, one friend had said 'have the baby and I will help you,' I would not have had the abortion." That woman did not have that friend.

So, let me say this today. You, as a Knight of Columbus are, and must continue to be, that friend. The Knights of Columbus has opposed abortion for thirty-five years and will continue to do so for as

long as abortion is legal. The Knights of Columbus must support women in their decision to have their child, women who believe that the right to life is the indispensable right for all human beings.

Northborough Knights of Columbus Aid Flooded Council in Vinton, Iowa

St. Augustine Council #5724 of Northborough, Massachusetts recently sent a cash donation to Marion Council #3893 in Vinton, Iowa to assist brother knights in the huge effort facing them in the clean-up and repair of their facility to resume normal operation. Like the thousands of K of C Councils throughout the country, the Vinton council is engaged in supporting charitable works within the local community. The Northborough K of C is assisting them in their effort to return to normalcy in the face of the disastrous floods that have spread through the Midwest.

The council to council connection comes from a personal friendship between Joseph McNamara, Grand Knight of the Northborough K of C and Paul Coyle, a former Massachusetts resident and Past Grand Knight of the Vinton council. Coyle and McNamara see each other once a year at a function in Boston and this year this council to council support program was developed.

According to Coyle, Vinton is a flooded area with electrical plants under 6 feet of water and they have been without electricity for a couple of weeks. The Public Works Department recently installed a large portable generator that supplies a small part of Vinton with power. The plan is to move the generator periodically to give all residents some power for a short period of time. Full power is not anticipated for at least another week as the flood waters begin to recede. Marion Council #3893 is also under 6 feet of water at this time and it has been unable to function in its usual support of the community. Plus the extraordinary cost to support the clean-up has members wondering how and if ever, they can return to normalcy. McNamara said that K of C councils have a way of supporting each other and mentioned the huge flow of dollars from the Massachusetts area into the south following the damage caused by hurricane Katrina.
